1.0 Ms. Holliday, Co-chair - Roll Call

Ms. Susan Holliday opened the meeting by welcoming the RAB members and the members of the public. RAB members were asked to provide current email addresses to insure accuracy as a number of emails sent to members were returned. Members of the public were invited to check the block on the sign in sheet if they wanted to be included on the SIAD mailing list. At the September 2007 RAB meeting, Mike Erickson, Paul Sutton and Amanda Davis stated they had not received an agenda. They were advised that the mailing list had been revised and updated insure they are not missed in the future.

2.0 IRP Sites, Hoa Voscott, ARCADIS

Mr. Hoa Voscott provided a summary of the background data and results of the Enhanced Reductive Dechlorination (ERD) demonstration programs at the DRMO and TNT sites.

At the Building 210 area, Hoa explained that we are seeing more evidence of positive effects from the ERD at this area. He also explained that the Soil Vapor Extraction pilot test was removing an appreciable amount of TCE and that the Army would be presenting the information in greater detail to California Department of Toxic Substances Control (DTSC) staff. It is hoped that we have sufficient evidence to lead us toward a solution at this site.

There were no questions or discussion on Mr. Voscott's topics.

3.0 Status of Honey Lake – Mike Erickson

A presentation was conducted by the Center for Urban Watershed Development to inform the RAB and community of the status of posting the Honey Lake area with warning signs. Mr. Herman asked that adequate signage be posted to insure people won't drive in or on the lake. There was some discussion concerning the removal of the bilingual signs. Mr. Erickson stated the signs were in place with heavy cement but the ice moved the signs. Mr. Garrod, Mr. Schlusler and Mr. Herman felt the current plans for signage was not protective and suggested that signs be placed at the more heavily accessed areas and at the "V" on the south end of the lake. Mr. Schlusler asked for additional signage and requested warning brochures be placed in local businesses; especially those who sell fishing licenses. It was also suggested that maps and signs be published in the Susanville and Reno newspapers.

4.0 Military Munitions Response Program (MMRP) – Susan Holliday

Ms. Holliday indicated that she was expecting the Site Investigation to be finalized any time and dependent on the timing, it could provide an agenda item for the next RAB.

4.1 Furnishing Documents to RAB members

Based on a request from Mr. Larry Beach at the preceding RAB meeting, a vote was held to determine if RAB members wanted to have all documents mailed to them, in addition to the repositories, for review. The vote was not to make that a policy, if RAB members want or need additional project information they would be given that information at the next RAB meeting.

5.0 Open discussion

Mr. Schlusler asked about what would be done on the old Demolition Area and stated he felt we should blow up all the old ammunition and get rid of it before it can cause harm. Ms. Holliday restated the current policy that includes emergency permits to destroy ammunition that is not safe to transport.

6.0 RAB Members - Proposed Agenda and Schedule Next RAB

RAB members agreed meet in the spring for a tour of the Installation Restoration and Military Munition Response Sites.

Ms. Holliday adjourned the meeting at approximately 8:40 pm.
