## I. Announcements

Attendance was taken for the meeting minutes. Minutes of the last meeting were not read for approval as the last meeting was a tour of the RAB sites, and minutes were not taken. This tour of the Installation Restoration Sites was provided to RAB members on April 21, 2006. A general discussion of the tour was held and the consensus was that the tour was well received and well done.

## II. Topics of Discussion

- a. Discussed DOD's Final Rule regarding the scope, characteristics, composition, funding, establishment, operation, adjournment, and dissolution of RABs. Copies of the May 12, 2006 Federal Register were provided to RAB members. IAW the Federal Register guidance: 1. there will be designated block of time on future RAB agendas for members of the public to speak.
  2. All future RAB meeting notices will be published in a local newspaper of general circulation.
- b. 1960's Demolition Area Fencing and posting of this area was completed.

c. Update Groundwater Cleanup Sites -TNT Leaching Beds and DRMO Trench—Five-year reviews are under preparation. Results of the Enhanced Reduction Dechlorination (ERD) were presented; the technology is not working very effectively at these locations. The five-year review at TNT will recommend stopping the ERD while continuing with Monitored Natural Attenuation. At the DRMO Trench, the review will recommend continuing

operation of the Soil Vapor Extraction System. Bldg. 210 Area – A pilot soil vapor extraction system is being installed east of building 211.

d. Abandoned Landfill/Southern Sites Area – A feasibility study suggesting the potential remedy to be a series of wells to be used to injecting a carbon source (ERD). Study is due to California EPA by August 28, 2006.

The meeting was adjourned at 8:30 pm by Susan Holliday. The next Restoration Advisory Board Meeting will be at 6:30 p.m. on 15 November in the Skedaddle Inn, unless a change is made due to inclement weather.
